Regulations and Agreement Specifics:

1. Booth registration fee includes temporary business permit.
2. All booths serving perishables and edibles are required to pass Health inspection and receive a Temporary Food Service permit from the Banks County Health Department. A sanitation station and photo of booth set-up is required. Please complete the enclosed application for the permit and return to the Banks County Health Department at 667 Thompson Street, Homer, GA 30547 **at least 5 days in advance**. See attached document for all Health Department requirements. For more information, contact the Banks County Health Department at 706-677-5009.
3. Food vendors must be **completely** set up no later than **2:00 pm on Friday September 2, 2011**.
4. All hot appliances must be contained safely from the public.
5. The Festival organizers' booth is the only booth authorized to sell carbonated drinks and water.
6. Booth registration fees are **NON-REFUNDABLE**.
7. Booth set-up will begin at 10:00 am Friday, September 2, 2011.
8. All vendors are requested to remain open through 4:00 pm, Sunday, September 4, 2011.
9. Booth space must be clean upon departure.

Vendor agrees to abide by the rules and specifications established by the Holiday Festival Committee and provided in this contract.

Festival location: I-85 to exit 149, North on Hwy. 441, turn left onto Hwy. 164/Historic Homer Hwy. Follow Historic Homer Hwy. into Homer.
