8. Lake Forest Drive Donna Gee

Donna Gee of Cobb Investments stated they had spent approximately \$30,000 on improvements of the road and asked that the county take on the maintenance of the road. She stated there was a handicapped child at the end that needed the school bus to pick them up. Comm. Duckett stated the work that had been done was good and that there were approximately 27 residences on the road. Vice Ch. Reece stated the milling currently on the road may prevent the road from being scraped and that the milling would have to be removed. Comm. Turk agreed and also stated the size of the cul-de-sac would be a problem to accommodate a school bus. He stated it would have to be 80 ft. Vice Ch. Reece stated driveway pipes must be installed especially on the right side of the road. He further stated that taxpayers' money should not be spent on fixing the road and that repairs should be made before the county assumes responsibility. Comm. Turk reiterated that the cul-de-sac had to be 80 ft. Comm. Maxwell stated Road Superintendent Wayne Andrews stated the current cul-de-sac would be sufficient.
