# 32260 - Jail / 33000 - Sheriff

Sheriff Speed stated when he was elected into office he transferred jail positions over to deputies and had never replaced them and would now like to get the jail staff back up to four persons per shift which was the standard.

Sheriff Speed said they were considering changing health care providers for the inmate health care. He stated the new providers have a doctor available that could come every week and they also have a nurse that could administer drug test.

Sheriff Speed stated the jail was over 10 years old and needed regular repairs and maintenance. He also stated at any time the heating and a/c units may need to be replaced.

Sheriff Speed also asked for five cameras for patrol cars. He stated the court system always asked for footage of the call.

Sheriff Speed also stated the vehicle lease purchase would end this year and he is asking to borrow money from the capital fund for three new cars until the 2017 SPLOST was available.

The total increase for the jail would be \$133,418 and the increase for the Sheriff's budget would be \$495,179. The total increase was an amount of \$629,209.
