Commerce Lucky Store

Hooper opened the hearing and stated that the purpose of the hearing was to consider the possible violation of furnishing alcohol to a minor and asked Investigator Shirley to present the violation allegations. Investigator Shirley stated that on March 27, 2015 at approximately 10:45 a.m., a DOR Underage Operative and Agent Maryellen Loggins, entered the 4 Way Country & Grocery and the Underage Operative proceeded to purchase a beer. He said the alcohol licensee Harshadkumar D. Patel did not ask for ID and sold him the beer. Mr. Patel admitted that the sell did occur and stated he had been under much stress due to personal reasons. Ch. Hooper pointed out the importance of maintaining safety for our teens and our county and asked what would be done in the future to prevent it from happening again. Mr. Patel stated he would check everyone's ID regardless of age.

Investigator Shirley stated that on March 27, 2015 at approximately 2:54 p.m., a DOR Underage Operative and Agent Maryellen Loggins, entered the Outback Steakhouse and the Underage Operative proceeded to purchase a beer. He said the server Loricia J. King did not ask for ID and sold him the beer. Manager Joshua Curry admitted that the sell did occur and stated the employee had been terminated. Ch. Hooper stressed the importance of a training program and asked what would be done in the future to prevent it from happening again. Mr. Curry stated increased training for employees would be required on a yearly basis.

Investigator Shirley stated that on March 27, 2015 at approximately 1:25 p.m., a DOR Underage Operative and Agent Maryellen Loggins, entered the Longhorn

Steakhouse and the Underage Operative proceeded to purchase a beer. He said the server Victoria Alexandria Wheeler did not ask for ID and sold the beer. Longhorn Steakhouse Attorney Kevin Leff was present at the meeting and clarified that the server did ask for the ID but when the underage operative did not furnish the ID, she sold him the beer anyway. Attorney Leff stated that according to Longhorn policies the employee had been terminated. Ch. Hooper stressed the importance of a training program and asked what would be done in the future to prevent it from happening again. Manager Gregory Ray stated training had been done immediately following the violation and more training would be required in the future.
