## Fire/EMS

Ch. Hooper stated the \$36,000 for the Training Officer needed to be placed back in the budget. He said the Fire Chief had stated the need for filling the position. Ch. Hooper made a motion to hire the Training Officer. There was no second to the motion. Motion died. Commissioners Turk, Reece and Duckett all requested that the Fire Chief appear at the next meeting to explain the need for the position.

## **Employee Salary Increases**

Ch. Hooper stated he felt the employee salaries should be increased by 3%. He also said it had been almost 7 years since a raise was given except for the 1% a couple of years ago when FICA had gone up 2%. He stated employees were living on wages of at least 1% less than in 2006. Comm. Reece stated he had no problem with raises but that he wanted to wait and review projected revenues before the decision. Vice Ch. Turk and Comm. Duckett agreed. Comm. Maxwell stated he was in support of employee raises. All committed to look for funds to provide for an increase.
