#### 7. PUBLIC HEARINGS:

a. CU 22-08 Application from Hodie Meats, Inc of 2850 Gainesville Highway Alto, GA 30510 for a Conditional Use. Property identified as map and parcel B12 003 1 to be used as a Food Processing/Further Processing (Not a kill site). The Conditional Use will not be on the entire property. It will only be on the back building and closely surrounding area which is approximately 202,781 square feet.

Ch. Turk closed the meeting and Atty. Frost opened the public hearing.

Atty. Frost stated that CU 22-08 was a conditional use application from Hodie Meats, Inc of 2850 Gainesville Highway Alto, GA 30510 for a Conditional Use. Property identified as map and parcel B12 003 1 to be used as a Food Processing/Further Processing (Not a kill site). The Conditional Use will not be on the entire property. It will only be on the back building and closely surrounding area which is approximately 202,781 square feet.

Planning Comm. Chairman Jay O'Kelley stated the Planning Commission recommended approval of the application with the following conditions:

Condition 1: Product must arrive fresh and cold. Product must leave fresh and cold.

Condition 2: Wastewater treatment plan must be approved by county public utilities director before operating on-site treatment plant.

Condition 3: All solid waste stored outdoors and removed daily.

Condition 4: Any solid waste that cannot be removed daily must be kept indoors.

Condition 5: No cooking or rendering permitted at any time.

Condition 6: Prominent signs directing trucks and employees to appropriate areas.

Condition 7: Any area that was used to stage trucks that became contaminated or soiled by leakage from trucks must be washed down into wastewater treatment system on a daily basis.

Eric Ayers – 2850 Gainesville Hwy, Alto – Stated that Hodie Meats was a processor that received fresh poultry and would then in turn alter the product whether cutting or seasoning the meat and sending them out to their customers like Chickfila, Popeyes and Zaxbys. He further stated it would be fresh in and fresh out, monitored by the USDA and there would also be onsite presence of the USDA.

Mr. Ayers stated they wanted to be an American owned company and had the mentality of America and the local community first. He stated that when they found the building, he found out there were a lot of displaced employees from 2 years ago when the business had closed. He hoped to hire some of those employees that have to travel outside of the area to work.

He further stated that the USDA monitored inside and outside of the facility including the waste and insect control. He continued to say they were Federally regulated for the production, processing and housing of the meat inside and outside the facility.

Vice Ch. Maxwell asked if the EPA or EPD was involved in the waste water and the water coming out? Mr. Ayers stated they test the waste and EPD monitors the processes.

Comm. Gardiner wanted to confirm that there would be no cooking of products. Mr. Ayers said there would be no cooking.

Ch. Turk asked how many employees they would have? Mr. Ayers stated they would start with 40.

Atty. Frost closed the public hearing and Ch. Turk opened the meeting.

Motion to approve the Conditional Use for the building with the condition to conduct business according to the letter of intent that was presented in the application.

Motion made by Chairman Turk, Seconded by Vice Chairman Maxwell. Voting Yea: Chairman Turk, Vice Chairman Maxwell, Commissioner Reece, Commissioner Gardiner Vote: 4:0
