a. Finance & Budgeting: FY2023 Budget Amendment - Randy Failyer

Mr. Failyer stated that the resolution was neither increasing or decreasing the FY2023 budget but was just adjusting the departments in order to get ready for the FY2023 audit.

b. 2023 Millage Rate - Becky Carlan

Ms. Carlan stated that the digest was up 20% and if the Commissioners took a rollback for the millage it would be the lowest millage rate since 1996. She further stated the proposed county millage rate including the roll back would be 6.354 mills.

Ch. Turk stated the State of Georgia requires assessments and all counties have to be 38% - 42% of the assessed value.

Ch. Turk thanked all the department heads and elected officials for keeping their cost down with their budgets.

Comm. Garrison stated he appreciated everyone's hard work and hopefully the Commissioners had been able to give a little tax relief to the citizens of Banks County.

Comm. Gardiner stated the County portion of the tax bill would only be approximately 31% and the remaining portion was the School System.

7. BOARD OF ELECTIONS

Ms. Garrison stated that the Board of Elections had been notified by their Elections Supervisor that she would be retiring at the end of 2023. She further stated the Elections Board had advertised for the position and had received two applications in which they held interviews during an executive session. She stated one applicant was a no-show and the other applicant which they have chosen to hire was Kelsey Barnes

which will begin the position on September 1, 2023. Ms. Garrison stated Ms. Barnes was the elections coordinator for Jackson County and was well qualified for the position.

8. PREVIOUS BUSINESS ACTION:

a. Tabled 6/27/2023: Z-23-04 - Bryan & Tawana Wood - An application has been submitted to rezone a 5-acre portion of the property identified as B51 025C, a 15.35-acre lot located at the intersection of Hwy 441 and McCoy Bridge Rd., from ARR to C2 to be used for a wholesale establishment with a special use for a storage yard for railway components.

Ch. Turk asked for a motion to untable the item and there was no motion.

9. CONTRACTS AND AGREEMENTS:

a. Development Authority Funds Agreement - Randy Failyer

Mr. Failyer stated the funds agreement that the County had with the Development Authority that began back in 2012 and had been continually renewed over the years but at this time there seemed to be adequate funding available for the Authority and they no longer needed financial assistance.

Mr. Failyer further stated he was asking the Commissioners to allow the Chairman to sign a letter to terminate the funding beginning calendar year 2023 with the understanding that the funds could be needed in the future.

Comm. Ausburn stated the Development Authority was delinquent on filing the Annual Authority Registration and Financials report and therefore wasn't in compliance so they were not eligible at the time for State funding.

a. Sheriff's Department: Tag Readers - Shawn Wilson

Chief Deputy Wilson stated he was the Sheriff's Office were requesting tag reader cameras. The cameras would help solve crimes any give the officers the ability to search through a database of license plates of vehicles that travel through the area of the cameras.

Mr. Wilson stated he was asking for the cameras to be put at the major ingress/egress of the county. The cost of the camera system would be \$47,000 the first year and \$40,000 per year after that.

The Commissioners stated they would have to research and consider the item at a later time.
