

IS YOUR APPLICATION PACKET COMPLETE?

- ☐ RELOCATION INSPECTION: Must have passed initial moving inspection
- ☐ APPLICATION: Completed application
- ☐ MH CONTRACT: Proof of purchase of pre-owned home
- ☐ SURVEY: A copy of your recorded survey or land plat
- ☐ SITE PLAN: A copy of your land plat showing the locations of the new residence, septic tank, well, easements, driveway, and any other existing buildings as well as county required setbacks.
- ☐ PROOF OF OWNERSHIP: Deed or other proof of land ownership
- ☐ SEPTIC APPROVAL: A septic tank approval/permit from Banks County Environmental Health.
- ☐ DRIVEWAY VERIFICATION: Photo of driveway entrance, marked with flags or stakes (may be submitted digitally to PlanningOffice@co.banks.ga.us)

IS YOUR MH SITE READY?

- ☐ Is your driveway entrance marked for addressing?
- ☐ Have you installed a permit box on-site?
- ☐ Have you installed erosion control such as silt fences where needed?
- ☐ Are you setback far enough from property lines and roadways?
