#### To Vote:

- 1. Use Black or Blue Ink to mark the ballot.
- 2. Completely fill in the empty oval to the left of the candidate name or choice in all races you wish to vote.
- **3.** If voting for a Write-In candidate, completely fill in the oval to the left of the Write-In selection, then write the name of the Write-In candidate in the space provided.

#### Warning

- Do NOT use red ink or felt tip pen to mark ballot.
- Do NOT circle, underline or mark through choices.
- Do NOT use check marks or X to mark ballot.
- Do NOT mark more choices per race than allowed.
- Do NOT sign, cut, tear or damage the ballot.

#### If you make a mistake or change your mind on a selection:

- A. Do not attempt to mark through the selection or attempt to erase. Write "Spoiled" across the ballot AND across the return envelope.
- B. Mail or return the spoiled ballot and envelope to your county board of registrars; a new official absentee ballot will be mailed to you.

<u>If you decide to vote in-person:</u> Surrender the ballot to the poll manager at an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot.

"I understand that the offer or acceptance of money or any other object of value to vote for any particular candidate, list of candidates, issue, or list of issues included in this election constitutes an act of voter fraud and is a felony under Georgia law." Continuation of 1% Special Purpose Local Option Sales Tax for Education Purposes (Vote for One)		
Shall a special one percent sales and use tax for educational purposes be imposed in Banks County for a period not to exceed twenty (20) calendar quarters and for the purpose of raising not more than \$38,000,000 of net proceeds by said tax, which shall go to the School District for the purpose of (i) adding to, renovating, modifying, improving, equipping, constructing and demolishing existing school buildings and facilities, transportation facilities, physical education/athletic fields and facilities, classrooms, agricultural facilities and other facilities including but not limited to roof, flooring, asphalt, and HVAC replacement; (ii) acquiring miscellaneous new equipment, fixtures, furnishings for the school district, including information technology equipment, computer hardware and software, safety and security equipment and other school equipment; (iii) acquiring, constructing and equipping new school buildings and facilities useful and desirable in connection therewith, including, but not limited to a College and Career Academy; (iv) acquiring school buses, transportation and maintenance vehicles and other school vehicles; (v) purchasing textbooks including E-books, devices, test prep materials and band
